

OTHER SERVICES BY ACTIVE GLOBAL

• Live-In Caregivers

- Foreign-trained nurses and nursing aides staying at the house of the patient and providing full time care
- Monthly Salary: \$600 to \$1,000
- One time agency fee: \$2,400 to \$3,200
- EA license: 13C6324

• Respite Care

- Local registered nurses who can support on short-term basis
- \$23 to \$40 per hour

• Interim Care Services

- 2 weeks of post-hospitalisation full time care
- Only by referral from the Hospital
- \$110 / shift before subsidy

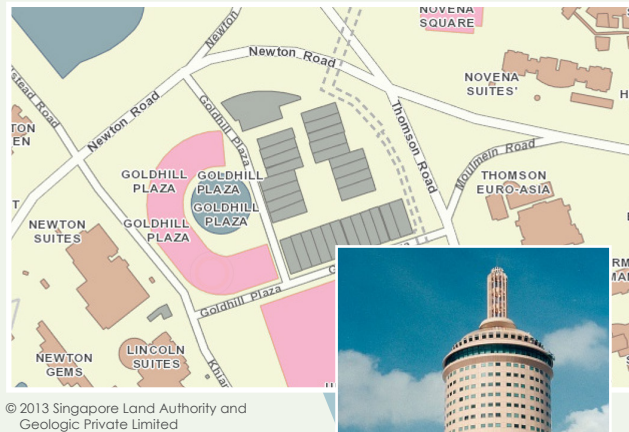

WHAT IS HOME PERSONAL CARE?

- Home Personal Care provides long-term subsidised home-based personal care to support frail and home-bound elderly who need assistance with daily activities.
- Operates 7 days a week, island-wide, 8am to 10pm.
- Our Care Assistants are locals. They are trained and supervised by our nurses.
- Our Nursing manager will conduct an assessment and design the Care Plan during the initial visit.
- Minimum service block of one hour only.
- The Scope of Home Personal Care Includes:
 - a. Personal hygiene
 - b. Assistance with activities of daily living (ADLs) and instrumental activities of daily living (iADLs)
 - c. Mind stimulating activities
 - d. Elder-sitting and respite
 - e. Assistance with medication
 - f. Performing simple maintenance exercises as prescribed by a registered physio-, occupational or speech therapist.

HOW MUCH DOES IT COST?

- \$22 / hour before subsidy (for subsidised clients).
- \$24 / hour for non-subsidised clients.
 - \$2.20 / hour surcharge after 8pm
 - \$22 / hour surcharge on Sunday
- Payment terms: weekly (or monthly) invoicing, payment to be settled before start of service

HOW TO GET THE SUBSIDY?

- A social worker will need to conduct a means-test.
- The results of the means-test will determine your subsidy-level.
- Call us for assistance.



EXAMPLE COSTS

- **Example 1:**

Mdm Tan engaged a Home Personal Care worker for 6 hours per week. After means-testing, the social worker determined that she is eligible for 80% subsidy.

→ **her 'out-of-pocket' cost is \$26.40 per week.**



- **Example 2:**

Mr Hamid engaged a Home Personal Care worker for 3 hours per week. After means-testing, the social worker determined that he is eligible for 50% subsidy.

→ **his 'out-of-pocket' cost is \$33.00 per week.**
